The open question of shear forces in heterogeneous plates



- Thick or Thin plates?
 - ► Thin Plate Kirchhoff-Love φ_α = U_{3,α}: asymptotic derivation, transverse shear effects neglected (Kirchhoff (1850); Love (1888); Ciarlet and Destuynder (1979))
 - ► Thick Plate Reissner-Mindlin φ_α ≠ U_{3,α}: axiomatic and controversial. Natural boundary conditions! (Reissner (1944); Hencky (1947); Mindlin (1951))
 - ... plates are generalized continua!

The open question of shear forces in heterogeneous plates



- Thick or Thin plates?
 - ► Thin Plate Kirchhoff-Love φ_α = U_{3,α}: asymptotic derivation, transverse shear effects neglected (Kirchhoff (1850); Love (1888); Ciarlet and Destuynder (1979))
 - Thick Plate Reissner-Mindlin φ_α ≠ U_{3,α}: axiomatic and controversial. Natural boundary conditions! (Reissner (1944); Hencky (1947); Mindlin (1951))
- Deriving formally Reissner-Mindlin plate model from asymptotic expansions?

The 3D problem configuration



The 3D problem equations

$$\begin{cases} \sigma_{ij,j}^{t} = 0 \quad \text{on } \Omega^{t}.\\ \sigma_{ij}^{t} = C_{ijkl}^{t}(x_{3})\varepsilon_{kl}^{t} \quad \text{on } \Omega^{t}.\\ \sigma_{i3}^{t} = \pm f_{i} \quad \text{on } \omega^{l\pm}.\\ \varepsilon_{ij}^{t} = u_{(i,j)}^{t} \quad \text{on } \Omega^{t}.\\ u_{i}^{t} = 0 \quad \text{on } \partial\omega^{L} \times] - t/2, t/2 \end{cases}$$

- ► monoclinic and even $\underset{\alpha,\beta,\gamma,\ldots}{\boldsymbol{C}_{\alpha\beta\gamma3}^{t}=\boldsymbol{C}_{333\alpha}^{t}=0},$ $\alpha,\beta,\gamma,\ldots=1,2.$
- symmetrically laminated plate
- ► symmetric transverse load <u><u>f</u> = f₃<u>e</u>₃</u>

 \Rightarrow pure bending:

- u_3^t and $\sigma_{\alpha 3}^t$ even / x_3
- u_{α}^{t} , $\sigma_{\alpha\beta}^{t}$ and σ_{33}^{t} odd / x_{3}

Proof of skew symmetry

Let $\underline{u}^{t'}$ be the image of \underline{u}^t by the symmetry with respect to the (x_1, x_2) -plane

$$\underline{\boldsymbol{u}}^{t'}(x_1, x_2, x_3) = \begin{pmatrix} +u_1^t(x_1, x_2, -x_3) \\ +u_2^t(x_1, x_2, -x_3) \\ -u_3^t(x_1, x_2, -x_3) \end{pmatrix}$$

Obviously, $\underline{\boldsymbol{u}}^{t'} = 0$ on $\partial \omega^{L} \times] - t/2, t/2[$. Its corresponding strain $\boldsymbol{\varepsilon}^{t'} = \underline{\boldsymbol{u}}^{t'} \otimes^{s} \boldsymbol{\nabla}$ is:

$$\varepsilon^{t'}(x_1, x_2, x_3) = \begin{pmatrix} \varepsilon_{11}^t & \varepsilon_{12}^t & -\varepsilon_{13}^t \\ \varepsilon_{12}^t & \varepsilon_{22}^t & -\varepsilon_{23}^t \\ -\varepsilon_{13}^t & -\varepsilon_{23}^t & \varepsilon_{33}^t \end{pmatrix} (x_1, x_2, -x_3)$$

Its corresponding stress $\underline{\sigma}^{t'}\left(\underline{x}\right) = \underline{c}^{t}\left(x_{3}\right) : \underline{\varepsilon}^{t'}\left(\underline{x}\right)$ is:



Because $\mathbf{\underline{C}}^{t}(x_3)$ is even and monoclinic, then:

$$\boldsymbol{\sigma}^{t'}(x_1, x_2, x_3) = \begin{pmatrix} \sigma_{11}^t & \sigma_{12}^t & -\sigma_{13}^t \\ \sigma_{12}^t & \sigma_{22}^t & -\sigma_{23}^t \\ -\sigma_{13}^t & -\sigma_{23}^t & \sigma_{33}^t \end{pmatrix} (x_1, x_2, -x_3)$$

Finally, the balance equation $\underline{\sigma}^{t'}\cdot \underline{\nabla} = 0$ is easy to check and we have:

$$\underline{\sigma}^{t} \cdot \left(\pm \underline{\underline{e}}_{3} \right) = -\underline{\underline{f}} = -f_{3}\underline{\underline{e}}_{3} \quad \text{on } \omega^{t\pm}.$$

Therefore,

$$\underline{\boldsymbol{u}}^{t'}\left(\underline{\boldsymbol{x}}\right) = -\underline{\boldsymbol{u}}^{t}\left(\underline{\boldsymbol{x}}\right), \ \underline{\varepsilon}^{t'}\left(\underline{\boldsymbol{x}}\right) = -\underline{\varepsilon}^{t}\left(\underline{\boldsymbol{x}}\right), \ \underline{\sigma}^{t'}\left(\underline{\boldsymbol{x}}\right) = -\underline{\sigma}^{t}\left(\underline{\boldsymbol{x}}\right)$$

Hence,

Variational formulation

The set of statically compatible stress fields is:

$$SC^{3D,t}: \begin{cases} \boldsymbol{\sigma}^{t} \cdot \boldsymbol{\nabla} = 0 \text{ on } \Omega^{t} \\ \boldsymbol{\sigma}^{t} \cdot \left(\pm \boldsymbol{\underline{e}}_{3} \right) = \boldsymbol{\underline{f}} \text{ on } \omega^{L\pm}, \end{cases}$$

The set of kinematically compatible displacement fields is:

$$\mathcal{KC}^{\mathbf{3D},t}: \begin{cases} \boldsymbol{\varepsilon}^{t} = \underline{\boldsymbol{u}}^{t} \otimes^{s} \boldsymbol{\nabla} \text{ on } \Omega^{t} \\ \underline{\boldsymbol{u}}^{t} = 0 \text{ on } \partial \omega^{L} \times] - t/2, t/2[\end{cases}$$

The strain and stress energy density w^{3D} and w^{*3D} are respectively given by:

$$w^{3D}\left(\varepsilon\right) = \frac{1}{2}\varepsilon: \varepsilon^{t}:\varepsilon, \qquad w^{*3D}\left(\varepsilon\right) = \frac{1}{2}\sigma: \varepsilon^{t}:\sigma$$

Potential energy

$$P^{3D}\left(\varepsilon^{t}\right) = \min_{\varepsilon \in KC^{3D,t}} \left\{ P^{3D}\left(\varepsilon\right) \right\}$$

The potential energy P^{3D} is given by:

$$P^{3D}\left(\varepsilon\right) = \int_{\Omega^{t}} w^{3D}\left(\varepsilon\right) d\Omega^{t} - \int_{\omega^{L}} f_{3}\left(u_{3}^{+} + u_{3}^{-}\right) d\omega^{L}$$

 $\underline{u}^{\pm} = \underline{u}(x_1, x_2, \pm t/2)$ are the 3D displacement fields on the upper and lower faces of the plate.

Complementary energy

The complementary potential energy P^{*3D} given by:

At the solution (Clapeyron's formula):

$$P^{3D}\left(\underline{\varepsilon}^{t}\right)+P^{*3D}\left(\underline{\sigma}^{t}\right)=0$$

Building a plate model?

For typical width *L* and thickness *t*, let $\frac{t}{I} \rightarrow 0$

- Solve a 2D problem, called the "plate problem"
- "fair" 3D displacement localization
- "fair" 3D stress localization

Differential system depending on a small parameter

We want to solve the following differential equation on [0, 1]:

$$u''(x) - \eta u(x) = 0, \ u(0) = 0, \ u(1) = a$$

where $\eta > 0$ is a small parameter.

The solution is trivial:

$$u^{\eta}\left(x
ight)=arac{\sinh\left(\sqrt{\eta}x
ight)}{\sinh\left(\sqrt{\eta}
ight)}$$

The limit of $u^{\eta}(x)$ as η goes to 0^+ is:

$$\lim_{\eta\to 0^+} u^\eta\left(x\right) = ax.$$

Taylor's series

Using Taylor's series:

$$\sinh\left(\sqrt{\eta}x\right) = \frac{\left(\sqrt{\eta}x\right)^{1}}{1!} + \frac{\left(\sqrt{\eta}x\right)^{3}}{3!} + \cdots$$
$$\sinh\left(\sqrt{\eta}\right) = \frac{\left(\sqrt{\eta}\right)^{1}}{1!} + \frac{\left(\sqrt{\eta}\right)^{3}}{3!} + \cdots$$

We obtain:

$$u^{\eta}(x) = ax + a_{\eta}^{1} \frac{x^{3} - x}{3!} + a_{\eta}^{2} \left(\frac{x^{5} - x}{5!} - \frac{x^{3} - x}{3!3!} \right) + \cdots$$

The method

• Write $u^{\eta}(x)$ as a series:

$$u^{\eta}(x) = u^{0}(x) + \eta^{1}u^{1}(x) + \dots + \eta^{i}u^{i}(x) + \dots$$

where u^i are unknown functions.

Inject this series in the differential system

$$u''(x) - \eta u(x) = 0, \ u(0) = 0, \ u(1) = a$$

and make null all the terms in η^i .

Solve the cascade system which determines the uⁱ

Resolution

The cascade system is:

Term in
$$\eta^0$$
 : $u^{0''}(x) = 0$, $u^0(0) = 0$, $u^0(1) = a$
Term in η^1 : $u^{1''}(x) = u^0$, $u^1(0) = 0$, $u^1(1) = 0$
....
Term in η^i : $u^{i''}(x) = u^{i-1}$, $u^i(0) = 0$, $u^i(1) = 0$

The solution is obtained by mathematical induction:

$$u^{0}(x) = ax, \ u^{1}(x) = a\frac{x^{3}-x}{3!}, \ u^{2}(x) = a\frac{x^{5}-x}{5!} - a\frac{x^{3}-x}{3!3!}, \cdots$$

Non-dimensional fields

We define the non-dimensional fields $(\underline{\textit{u}}, \underline{\varepsilon}, \underline{\sigma})$ as follows:

$$\begin{cases} \underline{\boldsymbol{u}}^{t} \quad (x_{1}, x_{2}, x_{3}) = \boldsymbol{L} \, \underline{\boldsymbol{u}} \quad (x_{1}/L, x_{2}/L, x_{3}/t) = \boldsymbol{L} \, \underline{\boldsymbol{u}} \quad (Y_{1}, Y_{2}, z) \\ \underline{\boldsymbol{\varepsilon}}^{t} \quad (x_{1}, x_{2}, x_{3}) = \boldsymbol{\varepsilon} \quad (x_{1}/L, x_{2}/L, x_{3}/t) = \boldsymbol{\varepsilon} \quad (Y_{1}, Y_{2}, z) \\ \underline{\boldsymbol{\sigma}}^{t} \quad (x_{1}, x_{2}, x_{3}) = \boldsymbol{\sigma} \quad (x_{1}/L, x_{2}/L, x_{3}/t) = \boldsymbol{\sigma} \quad (Y_{1}, Y_{2}, z) \end{cases}$$

The derivation rule for these fields is:

$$\begin{split} \boldsymbol{\nabla} &= \left(\frac{d}{dx_1}, \frac{d}{dx_2}, \frac{d}{dx_3}\right) \\ &= L^{-1}\left(\frac{\partial}{\partial Y_1}, \frac{\partial}{\partial Y_2}, 0\right) + t^{-1}\left(0, 0, \frac{\partial}{\partial z}\right) = L^{-1}\boldsymbol{\nabla}_{Y} + t^{-1}\boldsymbol{\nabla}_{z} \\ &= L^{-1}\boldsymbol{\nabla}^{\eta}_{(Y,z)} \end{split}$$

where

$${f \Sigma}^\eta_{(Y,z)} \coloneqq {f \Sigma}_Y + {1\over \eta} {f \Sigma}_z$$

Natural scaling of the stress

$$\begin{cases} \sigma^{t}_{\alpha\beta,\beta} + \sigma^{t}_{\alpha3,3} = 0 \\ \sigma^{t}_{\alpha3,\alpha} + \sigma^{t}_{33,3} = 0 \\ \sigma^{t}_{33}(\pm t/2) = \pm f_{3} \\ \sigma^{t}_{\alpha3}(\pm t/2) = 0 \end{cases} \Rightarrow \begin{cases} \sigma^{t}_{\alpha3} = -\int_{-t/2}^{x_{3}} \sigma^{t}_{\alpha\beta,\beta} du \\ \sigma^{t}_{33} = -\int_{-t/2}^{x_{3}} \sigma^{t}_{\alpha3,\alpha} du - f_{3} \end{cases}$$

$$\sigma^{t}_{\alpha\beta} \sim \eta^{0} \quad \Rightarrow \quad \sigma^{t}_{\alpha3} \sim \eta^{1}, \quad \sigma^{t}_{33} \sim \eta^{2} \quad \text{and} \quad f_{3} \sim \eta^{2}$$

The out-of-plane loading is scaled as:

$$\underline{f}(x_1, x_2) = \eta^2 \frac{F_3(Y_1, Y_2)}{2} \underline{e}_3$$

The non-dimensional 3D problem

The set of statically compatible fields can be rewritten as:

$$SC^{3D}: \begin{cases} \boldsymbol{\sigma} \cdot \boldsymbol{\Sigma}^{\eta}_{(\mathbf{Y},z)} = 0 \text{ on } \Omega = \boldsymbol{\omega} \times] - \frac{1}{2}, +\frac{1}{2}[,\\ \boldsymbol{\sigma} \cdot \left(\pm \underline{\boldsymbol{e}}_{3} \right) = \frac{\eta^{2}}{2} F_{3} \underline{\boldsymbol{e}}_{3} \text{ on } \boldsymbol{\omega}^{\pm} \end{cases}$$

The kinematically compatible fields becomes:

$$\mathcal{K}C^{3D}: \begin{cases} \varepsilon = \underline{\boldsymbol{u}} \otimes^{s} \overline{\boldsymbol{\Sigma}}^{\eta}_{(Y,z)} \text{ on } \Omega, \\ \underline{\boldsymbol{u}} = 0 \quad \text{ on } \partial \omega \times] - \frac{1}{2}, +\frac{1}{2}[\end{array}$$

The constitutive law becomes:

$$\underline{\sigma}(Y_1, Y_2, z) = \mathbb{Q}(z) : \underline{\varepsilon}(Y_1, Y_2, z)$$

$$\boldsymbol{\Sigma}^{\eta}_{(\boldsymbol{Y},\boldsymbol{z})} = \boldsymbol{\Sigma}_{\boldsymbol{Y}} + \frac{1}{\eta} \boldsymbol{\Sigma}_{\boldsymbol{z}}$$

Properties of the non-dimensional solution

For given $(\omega, \mathbb{Q}, F_3, \eta)$ where \mathbb{Q} is monoclinic and even in z, and under some regularity conditions, the solution of the non-dimensional problem is unique.

Obviously, due the change of variables $x_3 \rightarrow z$:

- u_3 and $\sigma_{\alpha 3}$ are even in z
- u_{α} , $\sigma_{\alpha\beta}$ and σ_{33} are odd in z

We have the following new properties:

- u_3 and $\sigma_{\alpha 3}$ are odd in η
- u_{α} , $\sigma_{\alpha\beta}$ and σ_{33} are even in η

Proof

New change of variable $z' = -\frac{x_3}{t}$ for the out-of-plane variable. The new non-dimensional fields $(\underline{u}', \underline{\varepsilon}', \underline{\sigma}')$ are defined by:

$$\begin{cases} \underline{\boldsymbol{u}}^{t} & (x_{1}, x_{2}, x_{3}) = L \underline{\boldsymbol{u}}' & (x_{1}/L, x_{2}/L, -x_{3}/t) = L \underline{\boldsymbol{u}}' & (Y_{1}, Y_{2}, z') \\ \underline{\varepsilon}^{t} & (x_{1}, x_{2}, x_{3}) = \underline{\varepsilon}' & (x_{1}/L, x_{2}/L, -x_{3}/t) = \underline{\varepsilon}' & (Y_{1}, Y_{2}, z') \\ \underline{\sigma}^{t} & (x_{1}, x_{2}, x_{3}) = \underline{\sigma}' & (x_{1}/L, x_{2}/L, -x_{3}/t) = \underline{\sigma}' & (Y_{1}, Y_{2}, z') \end{cases}$$

The new derivation rule for these fields is:

Effect of the transformation $\eta \rightarrow -\eta$ on the non-dimensional solution

The new non-dimensional fields $(\underline{\boldsymbol{u}}', \underline{\varepsilon}', \underline{\sigma}')$ are solutions of the same equations as for $(\underline{\boldsymbol{u}}, \underline{\varepsilon}, \underline{\sigma})$ where $F_3 \rightarrow -F_3$ and $\eta \rightarrow -\eta$:

First-order auxiliary problem

Displacement

We find that the second-order displacement field writes as:

The general form of the expansion

Stress localization as function of static variables

The stress field can be accurately approximated by:

$$\underline{\sigma}^{\mathsf{BG}} = \underline{\mathbf{s}}^{\mathsf{K}} : \underline{\chi} + \eta \; \underline{\mathbf{s}}^{\mathsf{K} \nabla} : \underline{\chi} \otimes \underline{\nabla}_{\gamma}$$

 $\chi = (\chi_{\alpha\beta}) (Y_1, Y_2)$ is an unknown symmetric second-order tensor field.

Choice of χ ?: The minimum of complementary energy!

The corresponding bending moment is:

Its gradient is:

The Bending-Gradient stress energy

Plugging σ^{BG} into the complementary energy of the full 3D problem leads to the following functional:

This sixth-order tensor is the compliance related to the transverse shear of the plate. It is positive, symmetric, but not definite in the general case.

Extended plate equilibrium equations

Link between shear forces and generalized shear forces

The Bending-Gradient statically compatible fields

The Bending-Gradient stress energy must be minimized over the set:

$$SC^{BG}: \begin{cases} \mathbf{R} = \mathbf{M}^{BG} \otimes \mathbf{\nabla}_{Y} & \text{or} \quad R_{\alpha\beta\gamma} = M_{\alpha\beta\gamma}^{BG} \\ \left(\mathbf{i} \in \mathbf{R} \right) \cdot \mathbf{\nabla}_{Y} + F_{3} = 0 & \text{or} \quad R_{\alpha\beta\beta,\alpha} + F_{3} = 0 \end{cases}$$



The Bending-Gradient constitutive equations

Now we define the generalized strains as:

Adding these equations leads to the following expression:

We identify the internal power obtained by dualization

Once the exact solution of the macroscopic problem is derived, it is possible to reconstruct the local displacement field. We suggest the following 3D displacement field where U^{BG} , Φ are the fields solution of the plate problem:

In conclusion: the Bending-Gradient theory completely coincides for homogeneous plates with the Reissner-Mindlin model.

Distance between the BG and the RM models

We introduce the following relative distance:

$$\Delta^{\mathsf{RM}/\mathsf{BG}} = \frac{\|\underline{b}^{\mathsf{W}}\|}{\|\underline{b}\|}$$

is the norm for Bending-Gradient compliance tensors and \mathbf{h}^{W} is the pure warping part of \mathbf{h} :

 $\Delta^{\text{RM/BG}}$ gives an estimate of the pure warping fraction of the shear stress energy. When the plate constitutive equation is restricted to a Reissner-Mindlin one we have exactly $\Delta^{\text{RM/BG}} = 0$.

Pagano's boundary value problem (Pagano, 1969)

CFRP layers with different orientiations: $F_3(Y_1) = -F_0 \sin \kappa Y_1$ where $\lambda = 1/\kappa = \frac{1}{n\pi}$, $n \in \mathbb{N}^{+*}$ is the non-dimensional wavelength of the loading.

Shear constitutive equation

Taking into account $R_{112} = R_{222} = R_{122} = 0$, $U_{3,2} = 0$, shear constitutive equation is rewritten in two parts.

A first part with unknowns involving active boundary conditions:

Assumptions

- ► The same 3D problem as for laminates but ^{*c*} (<u>*x*</u>) depends now on the three coordinates.
