The principle of minimum potential/complementary energy

Requires kinematically/statically admissible trial fields!

The principle of Hashin & Shtrikman (1962)

Nativer Motivation Construction of a (microstructure-dependent) trial field

Phase-wise constant trial fields: the most simple trial field

$$\hat{m{ au}}(m{x}) = \sum_{lpha=1}^N \chi_lpha(m{x}) \hat{m{ au}}_lpha$$
ndicator function of phase $lpha$
Constant (to be optimized)

Local descriptors of the microstructure

The χ_{α} at the observation point.

Macroscopic descriptors (Hashin and Shtrikman, 1962) Volume fractions only (isotropic materials)!

Phase-wise constant trial fields

- do not depend on neighborhood
- no (relative) length-scale in the resulting bounds

Additional local descriptors

- should remain simple (for evaluation of $\mathcal{H}(\hat{\boldsymbol{\tau}})$)
- aggregate microstructural info at and around observation point

The most simple such local descriptor

- local volume fraction
- arguably physically meaningful (Widjajakusuma et al., 1999)

The case of two-phase materials

$$\widetilde{f}(x,a) = \widetilde{f}_1(x,a) = 1 - \widetilde{f}_2(x,a)$$

Spherical windows Radius of spherical window Indicator function of phase α $\tilde{f}_{\alpha}(x,a) = \frac{1}{W} \int_{\|r\| \le a} \chi_{\alpha}(x+r) dV_r$ Volume of spherical window



The case of two-phase materials

Step 1 – Defining enriched trial fields

- Step 2 Evaluating the H&S functional \rightarrow The curse of isotropy!
- Step 3 Optimizing the resulting bound

Original trial field

$$\hat{\boldsymbol{ au}}(\boldsymbol{x}) = \sum_{lpha=1}^{2} \chi_{lpha}(\boldsymbol{x}) \hat{\boldsymbol{ au}}_{lpha}$$

Enriched trial field

$$\hat{\boldsymbol{\tau}}(\boldsymbol{x}) = \sum_{\alpha=1}^{2} \sum_{h=1}^{p} \chi_{\alpha}(\boldsymbol{x}) \tilde{\boldsymbol{f}}(\boldsymbol{x}, \boldsymbol{a})^{h} \hat{\boldsymbol{\tau}}_{\alpha h}$$
Constant (to be optimized



The functional of Hashin & Shtrikman

$$\mathcal{H}(\hat{\boldsymbol{\tau}}) = \frac{1}{2}\boldsymbol{E}: \boldsymbol{C}_0: \boldsymbol{E} + \boldsymbol{E}: \overline{\hat{\boldsymbol{\tau}}} - \frac{1}{2} (\widehat{\boldsymbol{\tau}}: (\boldsymbol{C} - \boldsymbol{C}_0)^{-1}: \widehat{\boldsymbol{\tau}}) - \frac{1}{2} (\widehat{\boldsymbol{\tau}}: \boldsymbol{\Gamma}_0[\widehat{\boldsymbol{\tau}}])$$

Two-point descriptors of the microstructure

$$Z_{\alpha h,\beta k}(\boldsymbol{r}) = \langle \chi_{\alpha}(\boldsymbol{x}) \tilde{f}(\boldsymbol{x},\boldsymbol{a})^{h} \chi_{\beta}(\boldsymbol{x}+\boldsymbol{r}) \tilde{f}(\boldsymbol{x}+\boldsymbol{r},\boldsymbol{a})^{k} \rangle$$

For isotropic microstructures

$$Z_{\alpha h,\beta k}(r) = Z_{\alpha h,\beta k}(\|r\|)$$

Two-point descriptors vanish!

Hill tensor of spheres~

$$\frac{1}{V}\int Z_{\alpha h,\beta k}(x-y)\boldsymbol{\Gamma}_{0}(x,y)\,\mathrm{d}V_{x}\,\mathrm{d}V_{y}=\left(Y_{\alpha,h+k}\delta_{\alpha\beta}-Y_{\alpha h}Y_{\beta k}\right)\boldsymbol{P}_{0}^{\not\downarrow}$$



$$\sum_{\alpha,h,k} Y_{\alpha,h+k} \hat{\tau}_{\alpha h} : (C_{\alpha} - C_{0})^{-1} : \hat{\tau}_{\alpha k}$$

$$\sum_{\alpha,h} Y_{\alpha h} E : \hat{\tau}_{\alpha h}$$

$$\mathcal{H}(\hat{\tau}) = \frac{1}{2} E : C_{0} : E + \underbrace{E : \hat{\tau}}_{\alpha,h-k} - \frac{1}{2} \underbrace{\hat{\tau} : (C - C_{0})^{-1} : \hat{\tau}}_{\alpha,h-k} - \frac{1}{2} \underbrace{\hat{\tau} : \Gamma_{0}[\hat{\tau}]}_{\alpha,h+k} \delta_{\alpha\beta} - Y_{\alpha h} Y_{\beta k} \hat{\tau}_{\alpha h} : P_{0} : \hat{\tau}_{\beta k}$$

Navier Step 3 – Optimizing the bound w.r.t
$$\hat{ au}_{lpha h}$$

Stationarity conditions

$$\sum_{k} Y_{\alpha,h+k} \left((\boldsymbol{C}_{\alpha} - \boldsymbol{C}_{0})^{-1} + \boldsymbol{P}_{0} \right) : \hat{\boldsymbol{\tau}}_{\alpha k} = Y_{\alpha h} \left(\boldsymbol{E} + \sum_{\beta,k} Y_{\beta k} \boldsymbol{P}_{0} : \hat{\boldsymbol{\tau}}_{\beta k} \right)$$

Solving the linear system

Remember

$$\hat{\boldsymbol{\tau}}_{lpha k} = \mathbf{0} ext{ for } k
eq 0! \qquad \qquad \hat{\boldsymbol{\tau}}(\boldsymbol{x}) = \sum_{lpha, k} \chi_{lpha}(\boldsymbol{x}) \tilde{\boldsymbol{f}}(\boldsymbol{x}, \boldsymbol{a})^k \hat{\boldsymbol{\tau}}_{lpha k}$$

Standard bounds of H&S are retrieved :-(

Natier Conclusion and perspectives

All these developments for nothing?

- Enrichment led to no improvement!
- Extends to a wider class of trial fields!

However...

- Approach might apply to other situations.
- Was well worth trying (if only to spare the time of others!).

Perspectives

- Analysis suggests enrichments with better prospects (maybe).
- Isotropy is the root of our misfortunes: anisotropic descriptors?

$$\langle \chi_{\alpha}(\mathbf{x}) \Phi_{\mathbf{h}}(\mathbf{x}) \chi_{\beta}(\mathbf{x} + \mathbf{r}\mathbf{n}) \Phi_{\mathbf{k}}(\mathbf{x} + \mathbf{r}\mathbf{n}) \rangle = \text{func.}(\mathbf{r}, \mathbf{n})$$
